General conditions for Agromek 2021

1. *By signing this registration form, the Exhibitor agrees to comply with the attached "General Terms and Conditions for Agromek 2021" and "MCH Regulations".*
2. The Exhibitor may only exhibit new products. By further agreement, the Exhibitor may exhibit products for test or demonstration purposes, provided such products are new.
3. The Organiser will allocate a stand location to the Exhibitor. The Organiser reserves the right to change the stand location at a later date, and to change and/or impose limitations on the stand, should this be required for technical or other reasons. In the event of any changes, the stand rental fee will be adjusted to the actual size of the final stand.
4. The Exhibitor is not permitted to lend or rent the allocated stand out to a third party. Any companies to be represented at the stand must be registered as an accompanying exhibitor on the registration form. This is also required in order to be listed in the Agromek 2021 list of exhibitors.
5. The Exhibitor must in all circumstances and throughout the duration of Agromek 2021 comply with the Organiser's reasonable instructions.
6. Walls, signage, cleaning and additional technical orders are not included in the stand hire fee and must be ordered via the Exhibitor Manual, which may be requested from MCH Messecenter Herning A/S.
7. Should the Exhibitor order stand walls of three metres or more in length, please note that it will be necessary to use perpendicular support walls to ensure stability. As standard, the Exhibitor is permitted to erect stand walls of up to three metres in height. If the Exhibitor wishes to build a taller stand, this must be approved in advance by the neighbouring exhibitors. We request that all builds obtain approval via teknisk@mch.dk.
8. If the Exhibitor wishes to construct a two-storey stand, Agromek must be advised of and approve such a request in advance.
9. Registration is binding for the Exhibitor. However, cancellation is permissible in accordance with the following rules:
 - a) Upon cancelling a stand booking prior to 1 February 2020, a cancellation fee of 50 per cent of the full stand hire and registration fee will be charged.
 - b) Upon cancelling a stand booking on 1 February 2020 or later, the full stand hire and registration fee will be charged.The amounts stipulated in a) and b) above shall be payable regardless of whether the Organiser is able to relet the stand.
Stand cancellation must be submitted in writing to the Secretariat – preferably via e-mail to ag@agromek.dk.
Registration is binding for the Organiser, unless the Organiser has informed the Exhibitor by no later than 15 February 2020 that the registration has not been accepted.
10. The Organiser is entitled to use the Exhibitor's name in advertisements etc. for marketing purposes without being required to pay the Exhibitor any remuneration.
11. The Exhibitor carries the full risk for any loss and/or damage caused to the exhibited products as the result of fire, theft, water damage and/or any other damage sustained during shipment and/or the duration of the expo. The Exhibitor is also liable for any personal injury or material damage caused by the Exhibitor or any of its employees. The Exhibitor is advised to take out insurance that covers theft, fire and transport.
12. In the event that the Exhibitor fails to attend Agromek 2021, including failing to decorate and staff their stand, the Organiser reserves the right to decorate the booked stand space with furniture etc. at the Exhibitor's expense.
13. In the event that Agromek 2021 – due to force majeure or other incident(s) that the Organiser could not reasonably have been expected to foresee at the time of establishing the event or prior to registration – is postponed, held at a different time, moved, held wholly or partially at another location(s), or cancelled, the Organiser can in no way be held responsible, including not being responsible for any potential expenses, liabilities and/or loss incurred by the Exhibitor in this regard.

The Organiser reserves the right to regard any incident that leads to the authorities issuing a ban on convening animals due to the outbreak of foot and mouth disease, or African or classical swine fever, as force majeure. Also the organiser is entitled to consider any case where the authorities either prohibit or encourage many people not to gather because of virus outbreaks, epidemics or other extraordinary events, as force majeure.

In the event that Agromek 2021 is postponed, held at a different time, moved, held wholly or partially at another location(s), or cancelled in accordance with point 13, any payment for stand hire shall be refunded. In such cases, the Exhibitor cannot make any further claims against the Organiser.
14. All stipulated prices are exclusive of VAT. Terms of payment are 14 days net from the invoice date. In the event of overdue payment, interest will be charged at a rate of 2.0 per cent per started month.
15. In the event of a disagreement between the parties which cannot be settled, the case shall be brought before a competent court in the Organiser's domicile and shall be conducted in accordance with Danish law.
16. Agromek reserves the right – on the basis of impartial and objective grounds – to approve or reject each exhibitor's participation in the expo. In the event that an Exhibitor cannot be approved for participation, the Exhibitor shall receive a written explanation for this decision no later than one month after signing the contract.
